

# Guidance for Seculars from the Ratio on Membership in Other Groups with Distinct Spiritualities

Ratio 63 states: A divine call is always a mysterious grace that cannot be reduced to a list of qualities. But there are certain qualities that indicate that a person is essentially suited to the vocation of a Secular Carmelite. Ratio 64, 65, and 66 it go on to list some of these qualities.

Ratio 67 then addresses counter indications, and the one being specifically addressed here is: **membership of organizations with a distinct spiritual path.** 

Examples of associations with different spiritualities would include the Franciscan Order, the Order of Malta, and the Legion of Mary. If someone feels called to Carmel and is coming to a O.C.D.S. community to explore this spiritual path, it should be explained to them that the life of a Carmelite Secular is a vocation that has a unique spirituality, and members cannot belong to other such groups. They need to be advised they cannot belong to both and will eventually need to pray and discern about the direction of the journey God is calling them to prior to a Carmelite promise.

If any community discovers that a promised/vowed person belongs to a conflicting spiritual group, the leader should contact their Regional Provincial Councillor for procedural information.

### **Reminder—Money Matters**

A reminder to everyone that all community/group bank accounts are to be held in the name of the community/group. Likewise, all disbursements must be made through that same bank account. No community account may be in the name of an individual member, nor is it permissible to comingle OCDS funds with the personal funds of any member(s). More to the point, no member may hold OCDS funds in their own personal bank account.

All OCDS bank accounts should have two members as signatories, one of whom should be the treasurer. Whenever any cash is handled, two persons should be present when the monies are counted, one of which should be the treasurer. Constitution #55 states that the duty of the Treasurer is to take charge of the administration of the funds of the community. The Treasurer is to present a report of the funds to the Council every six months, and to the community and the Provincial Delegate once a year. Provincial Statutes Sec. XX No. 3 requires that the annual financial report to the Provincial Delegate shall be submitted no later than February 28th of each year.

Anyone who handles money for their community is reminded that they are called to be good stewards of finances and guardians against any liability which puts the non-profit status of the community or Province at risk.

#### **Assistance for Small Groups**

During the OCDS Leadership Workshop in May, there were several questions by group leaders requesting additional information and assistance concerning how small groups can accomplish everything larger groups and canonically established communities are called to do. These questions covered areas dealing with formation, how different levels of formation can progress when there are insufficiently professed members to have an adequate number of established formators, how to best divide the four hours of meeting time into effective segments with only a few people. How do we have community formation if there is no one to speak? Can someone who is not definitively professed be a formator? How can we open a bank account with small amounts of money in our collection of dues? How does a small group council run efficiently?

Jim Dowd, the Provincial Council President and the Regional Representative for the Mountain Region, has always belonged to small groups and has helped other groups with these types of questions.
